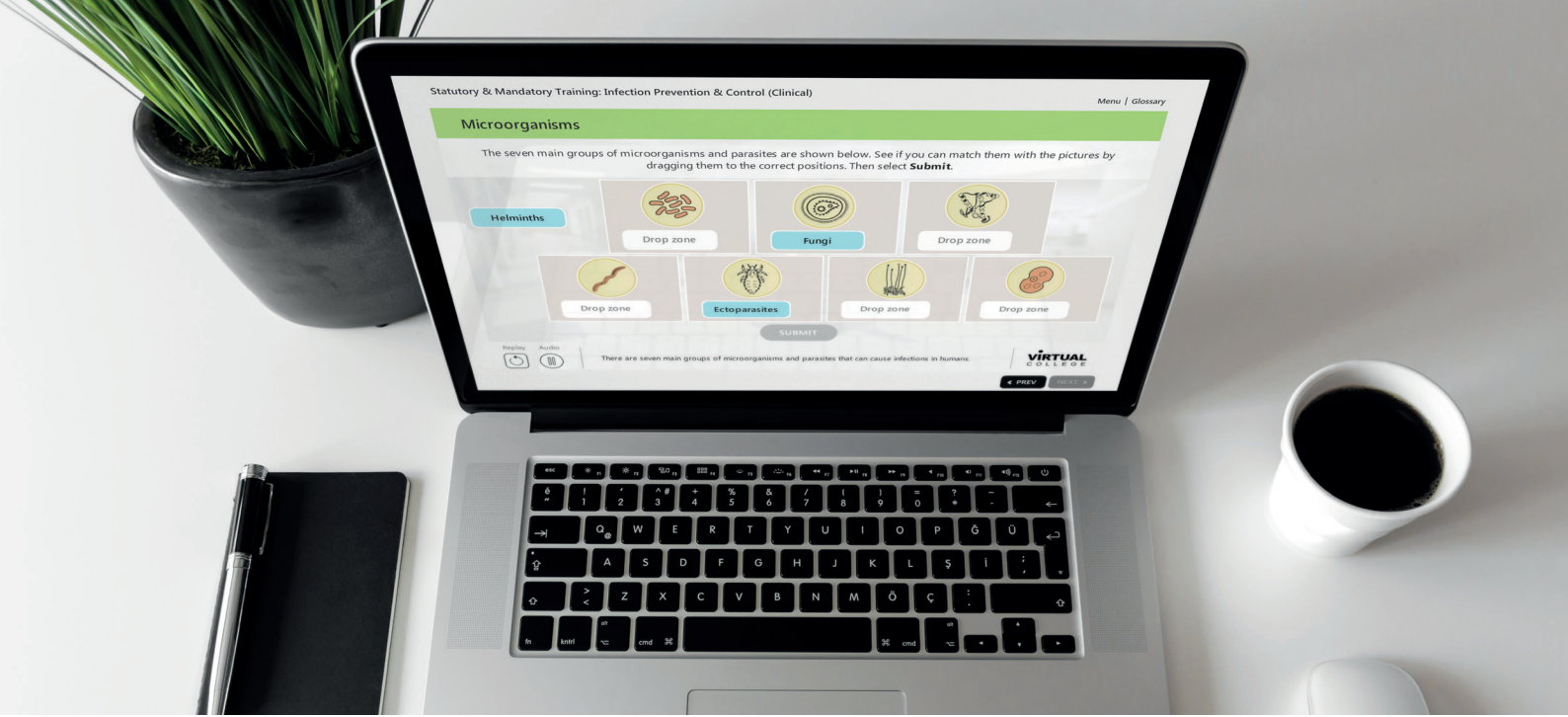

## How it works

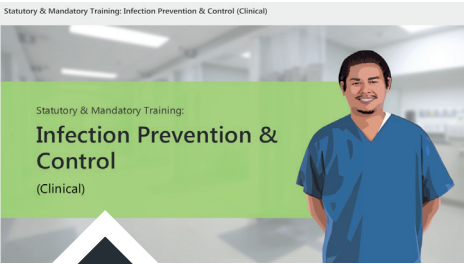
1. Select the courses you want in your package
